These amendments are based on a Court Order issued on October 18, 2024. The goal is to address various deficiencies in the outdated bylaws from 1983 and to clarify terms and language, ensuring compliance with current governance and operational standards for non-profit associations.

According to our existing bylaws, a two-thirds (2/3) majority of the quorum present at this meeting is required for the adoption of these changes.

**7. PRESIDENT REPORT**

Dear Members,

Thank you for attending the association's Annual General Meeting (AGM) today. Your participation is vital in helping to restore the association to normalcy fairly and transparently. We are committed to keeping you informed every step of the way.

On October 18, 2024, a significant milestone was achieved when Justice M. McGuire delivered a verdict in our board's favour, confirming our rightful place on the ATTA governance board since 2020, following a three-year governance dispute. This court order reaffirmed our position and recommended updating our outdated bylaws. It also mandates holding our next AGM in June 2025, as we did not have one in the year 2024. Members will vote on the revised bylaws, and all executive positions will be subject to election during this AGM.

We have informed TTCAN, the Sport, Physical Activity and Recreation Branch (SPAR), and AGLC of the court order, affirming that we are ATTA's current governance board. Our goal is to smoothly and promptly resume ATTA's operations.

In response, TTCAN's board had granted us provisional member status with the following actions:

- Accept all tournaments held in Alberta as of January 1, 2025, for ratings.
- Allow Alberta umpires and referees to be eligible for selections by TTCAN.
- Ensure that Alberta athletes remain eligible for national and international selections.

To gain full recognition as a "member in good standing" of TTCAN, we must meet the following conditions:

1. The ATTA must hold an AGM in the first half 2025.
2. The ATTA must adopt new bylaws as directed by the court.
3. All members from September 1, 2020, up to two weeks before the ATTA AGM, must be allowed to participate and vote at the AGM and to renew their membership if it has expired or been suspended.

We are pleased to report that we have met all the conditions set by TTCAN.

The SPAR and AGLC have also indicated that they are waiting for the AGM results so we can apply for funding.

Since the court order on October 18, 2024, we have taken significant steps to restore ATTA to its full potential. In January 2025, we actively reached out to clubs and individuals, inviting their participation, and sent out membership applications to all clubs across Alberta. We also promoted these opportunities on our website and social media platforms to maximize engagement.

We promptly reopened our bank accounts and gained access to our office with the support of SPAR. Despite facing a limited budget, we successfully delivered the Alberta junior team training program without any funding from SPAR or AGLC. Furthermore, we've revitalized our social media channels and website, enhancing communication and connection with our members and the wider public. We invite you to be part of our continued growth and success!

Upon reviewing our financial records following the reopening of ATTA's bank accounts, we identified a significant withdrawal from the general account in April 2022, during a period of governance uncertainty. At that time, ATTA was undergoing internal disputes, and leadership roles were contested. A bank-issued document indicates that a draft in the amount withdrawn was issued to the former president. We are currently working to understand how access to the account was obtained under those circumstances.

On January 15, 2025, we reported the transaction to the Edmonton Police Service. According to their latest update, the investigation is ongoing and pending additional documentation from the bank.

On February 7, 2025, ATTA initiated a civil claim to seek recovery of the funds in question. The claim names three individuals who were associated with the prior administration. We are currently awaiting their response through the legal process.

In addition, a counterclaim was filed in March 2021 concerning financial discrepancies identified during the former program coordinator's tenure. This matter has remained unresolved due to the ongoing governance dispute. With the current governance structure now in place, the ATTA board has authorized legal counsel to revisit the case and proceed with the appropriate steps.

We are working tirelessly to recover over six figures from the previous administration. These funds were intended to promote table tennis in Alberta, subsidize junior to national and international competitions, and serve Alberta table tennis players at all levels. We are unwavering in our commitment to recover the funds for the Alberta Table Tennis Community and ensure they are used for intended purposes.

When writing this report, we have stabilized our operations back to nearly normal. Operating without funding from SPAR and AGLC is a challenge, as we are working with a very tight budget. However, we strive to provide a quality training platform for our juniors in preparation for the national table tennis championship in Vancouver in July 2025.

We proudly announce that over 40 juniors from various age categories, both boys and girls, actively participate in the provincial team training program. We extend our gratitude to the parents of these junior players for their support and understanding of our current unfunded situation and for their willingness to collaborate with us to overcome the challenges we face.

We are working diligently to restore the association and put past differences aside.

We have gathered 2306 members from various clubs across our province, and you are here today to witness this process.

Our mission is to serve the best interests of the Alberta Table Tennis community. We aim to work collaboratively with TTCAN, SPAR, and AGLC to promote table tennis in Alberta and to restore public trust.

## **9. COACHING TEAM REPORT**

### **2025 Summary of Coaching Report**

Thank you for the opportunity to provide the coaching report for the 2024-2025 Season.

I would like to briefly introduce our Coaching Team:

Based in Edmonton we have coaches Kenny Li, and Ling Wang.

Based in Calgary there is myself, Phillip Xie.

- Also with our coaching team is coaching advisor, Coach Shu Ying Li from Edmonton to assist with all areas of our training program;
- As well, we engage assistant coaches to work with us in the training programs. They are Will Mak, and Jeremy Li from Calgary.

Since our last report at the ATTA's SAGM on June 13, 2023, our coaching team continued to work diligently through the 2024-2025 training season to provide training and coaching for juniors of the Provincial Team Training Program in both Edmonton and Calgary.

- Other than regular training during the season, we have also organized training camps in winter 2024 and spring camp in 2025 to strengthen developed skills. We will be running the summer camp in the beginning of July with intensified training to help our juniors prepare for the 2025 Canadian Championships coming up in mid July.
- After the ATTA's governance issue was resolved in late October 2024, we were able to open up team selection to all juniors in Alberta to train with our Long-Term Athlete Development Program. We began by offering a tryout for all Alberta juniors to enrol in

our program, and received a huge turnout of over 40 young players at all skill levels from both Edmonton and Calgary. We currently have 19 juniors in Edmonton, and 26 in Calgary, training with us.

- At the same time, we made an offer never been done in the history of the ATTA, where we opened up tryouts to all juniors in Alberta, no matter where they are trained, to have a chance at representing our province as Team Alberta at the 2025 Canadian Championships this year. In doing so, we held two tryouts during the season, the first was in Calgary during December 2024, and the second was in Edmonton during March 2025. Again, over 40 active young players competed at the tryout tournaments, and Team Alberta has been selected. Our province will have top 3 players from each of U13, U15, and U19 age categories for both boys and girls ready for the team event at nationals this year. We also have a number of U11 players joining nationals this year for the first time.
- Our team's understanding is that, Alberta will once again be able to participate in the Team Event at nationals this year if all goes according with TTCAN's recognition of this AGM as a step to full member-in-good-standing with TTCAN. Our team has not been able to participate at all during the 4 years of dispute, and we are hoping for a successful inclusion of Team Alberta this year.
- We hope that all our efforts and persistence will be the beginning for the next Canada Winter Games in 2027, when Alberta juniors did not have the chance to participate in year 2023 because of the dispute.
- We are very proud of the growing progress of our young provincial team, and deeply appreciate the recognition of our work by team parents who have put their trust in our coaching, and been tirelessly supporting our training program throughout the hardship of the association during the recent years. We hope for better days to come as we move forward.

In planning ahead, our coaching team shall continue with the ongoing progress such as:

- Continue to provide competitive level coaching, and quality training in our programs.
- Initiate and assist in providing more opportunities for table tennis events in our province, and training activities, for junior players in Alberta.
- Continue the development of younger Junior Hopes Program players with our long-term development program.
- Promote and provide opportunities for more women and girls involvement in the sport, and continue to open to gender-diverse, and ethnic diverse young players, in the sport of table tennis.

We believe these plans continue to be very important to the future of table tennis in Alberta.
