Cancellation/Refund: The tournament committee may modify, combine or cancel events based on the number of entries.

Refund of entry fee on event(s) canceled by the player is allowed before 5pm on Wednesday February 5th. After that time, there will be no refund on canceled or defaulted events (except on events canceled by the Tournament Committee). Players are responsible for the full payment of entry fee on their registered events.

TOURNAMENT RULES & INFORMATION (cont.)

Entry Deadline: 9:30 pm, Monday, February 2nd, 2026.

Draw: 6:30 pm, Wednesday, February 4th, 2026 at CUSTTA.

Non-Rated and New Players: May enter any events but subject to Tournament Committee's discretion.

Eligibility: Open to everyone.

Classification: January 2026 TTT ratings – please visit <http://sites.google.com/view/tcubeonline> for details about TTT Ratings. Latest ITTF laws apply to all matches.

Clothing: Main color of playing shirt, short or skirt, shall not be in white color. Tracksuit bottom may be worn during play with the permission of referee. Non-marking sole shoes must be worn inside the gymnasium.

Team Event format: Each team, as specified in each event, shall have two players (2P) or three players (3P) events:

For 2P, the match sequence is AB-XY, A - X, B - Y; and

for 3P, the match sequence is BC-YZ, A - X, C - Z, A -Y, B - X.

Team event draw format will be one of the followings, depends on the number of entries, to be determined by the referees at the Draw:

(a) 1st Stage Round Robin (RR); top two teams in a RR group advance to Single knock-out round; or

(b) 1st Stage Round Robin (RR); top two teams in a RR group advance to Single knock-out round, the rest go to consolation round; or

(c) 1st Stage RR; top team in a RR group to Division A, 2nd team to Division B, remaining teams in the same group to Division C, then RR or knock-out.

Under 600(2P) Team: Combined rating must be 600, or under.

Under 600-Seniors (2P) Team: Combined rating must be 600, or under. Player must be born in or before 1966.

Under 1200(2P) Team: Combined rating must be 1200, or under.

Under 1800(2P) Team: Combined rating must be 1800, or under.

Under 2400(3P) Team: Combined rating must be 2400, or under.

Under 2500(2P) Team: Combined rating must be 2500, or under.

Open Team(3P): No limit on combined rating.

Entry Events: Maximum 2 events on Saturday. **Player cannot enter events that start at the same time.**

Matches & Events: All matches in a team event are best of 5 games.

Prizes: Trophies, medals or plaques will be awarded to the winner and runner-up teams in all events. Cash prize to winner and runner-up of the Open team event, exact amount to be determined.

Cash prize, if any, for all other events to be determined and will be announced prior to the tournament.

Umpires: Umpires will be assigned for Semi-finals and Finals matches. Players can request for an umpire for any match if needed.

Default: Five minutes late for a match after your name is called. If you're leaving the gym, please check with the Control Desk for the time of your next match.
