<u>Payment:</u> Cash or cheque made payable to "Edmonton Intergenerational Sports and Wells Association". Online payment option is available when using online registration. Interac e-Transfer to <u>eiswa2025@gmail.com</u>, please include player name and a complete list of events entered in message when using Interac e-Transfer. Your fee must be paid before your first match.

<u>Cancellation/Refund</u>: The tournament committee may modify, combine or cancel events based on the number of entries.

Refund of entry fee on event(s) canceled by the player is allowed before 5pm on Wednesday October 22, 2025. After that time, there will be no refund on canceled or defaulted events (except on events canceled by the Tournament Committee). Players are responsible for the full payment of entry fee on their registered events.

TOURNAMENT RULES & INFORMATION (cont.)

Draw: 6:30 pm, Wednesday October 22, 2025

Non-Rated and New Players: May enter any events but subject to Tournament Committee's discretion.

Eligibility: Open to everyone.

<u>Classification:</u> October 2025 or the latest available ratings from TTCAN will be used. Latest ITTF laws apply to all matches.

<u>Clothing:</u> Main color of playing shirt, shorts or skirt, shall not be in white color. Tracksuit bottom may be worn during play with the permission of referee. Non-marking sole shoes must be worn inside the gymnasium.

<u>Junior Singles:</u> U-19: Born in 2007 or later; U-15: Born in 2011 or later; U-13: Born in 2013 or later. Players can enter the event of their own age group and one event of higher age group.

<u>Under 600 Singles:</u> Rating must be 600, or under. <u>Under 900 Singles:</u> Rating must be 900, or under. <u>Under 1500 Singles:</u> Rating must be 1500, or under.

Under 2000 Doubles: Combined rating must be 2000, or under.

Team Events Format: 3-Player Teams ABC/XYZ, Match #1: BC
vs. YZ; Match #2: A vs. X; Match #3: C vs. Z; Match #4: A vs. Y if

necessary; Match #5: B vs. X if necessary.

Team A: Combined rating must be 2000, or under; each player's

rating must be 1000, or under.

Senior Singles/Doubles: Born in 1960 or before.

Over 50 Singles: Born in 1975 or before.

Entry Events: Maximum 4 events per day, **cannot enter events that start at the same** time

<u>Matches & Events:</u> All matches are best of 5. Exception: Semi-finals, Final in the Open Singles event are best of 7.

Prizes: Trophies, or medals, or plaques will be awarded for the winner and runner-up in all events. There will be cash prize to the winner(s) and runner-up(s) of Open Singles and Open Doubles events (Amount of cash prize to be determined by the tournament committee and will be announced at the tournament).

<u>Umpires:</u> For Semi-finals, Finals, umpires will be assigned. Only players participating in a match may request an umpire for that match if needed.

<u>Default:</u> Five (5) minutes late for an event after your name is called. If you're leaving the gym, please check with the Control Desk for the time of your next (or remaining) match(es).

ATTA Membership Fee:

A current ATTA membership (individual or affiliated club member) is a requirement for all participants in the province; otherwise, \$15 (\$10 for junior/senior) ATTA individual membership fee will be charged. You must provide proof of membership when registering for the tournament.
